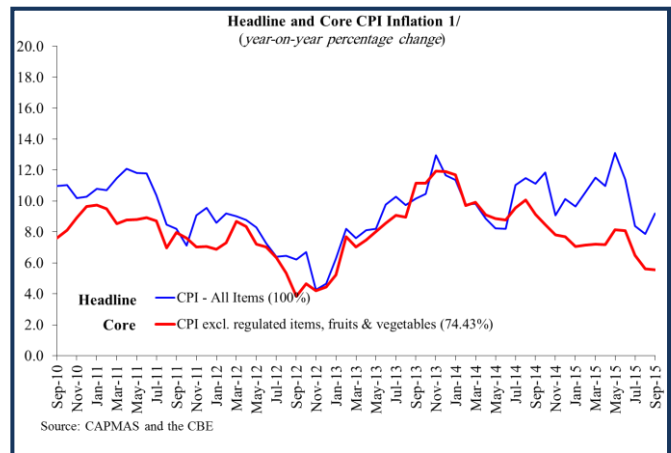
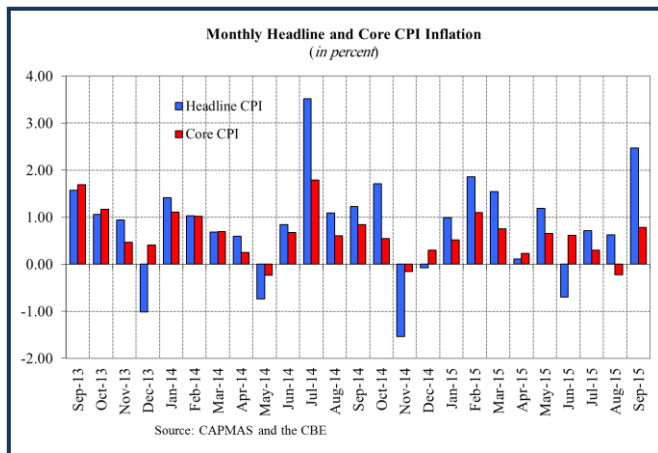


Headline and Core Inflation – October 2015

Headline CPI published by the Central Agency for Public Mobilization and Statistics on November 10, 2015, increased by 2.17 percent (m/m) in October 2015 compared to an increase by 2.47 percent (m/m) in September. The annual rate increased to 9.70 percent in October from 9.21 percent in September. The bulk of the monthly increase was driven by the acceleration in the prices of fresh vegetables together with the inch up in the school tuition and private lessons and the increase in the prices of restaurant services. Meanwhile, core CPI computed by the Central Bank of Egypt increased by 1.23 percent (m/m) in October 2015 compared to an increase of 0.79 percent (m/m) in September. The annual rate increased to 6.26 percent in October from 5.55 percent in September. Meanwhile, the prices of paid services, other services and retail items increased by varying degrees¹.

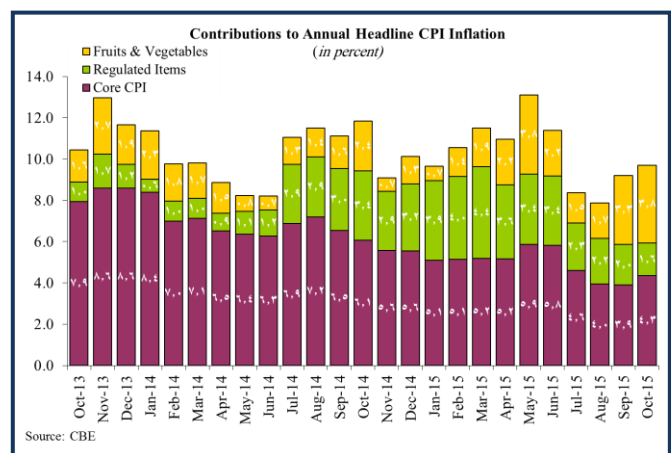
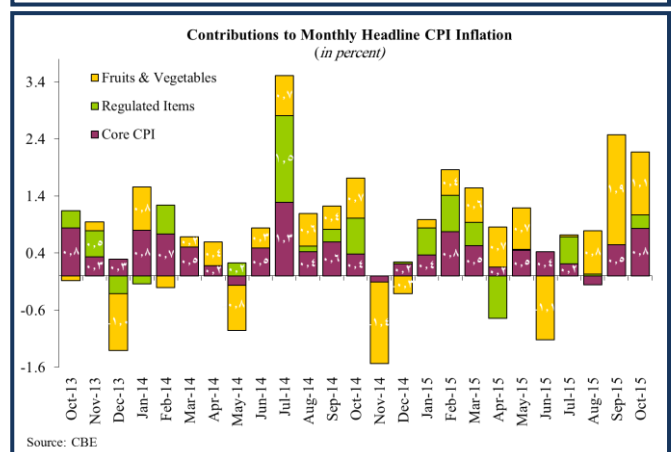


1. Headline CPI²

Headline CPI increased by 2.17 percent (m/m) in October 2015 compared to an increase by 2.47 percent (m/m) in September, which is above the average monthly pace of 0.98 percent recorded during the first nine months of 2015. The annual rate increased to 9.21 percent in October from 9.21 percent in September.

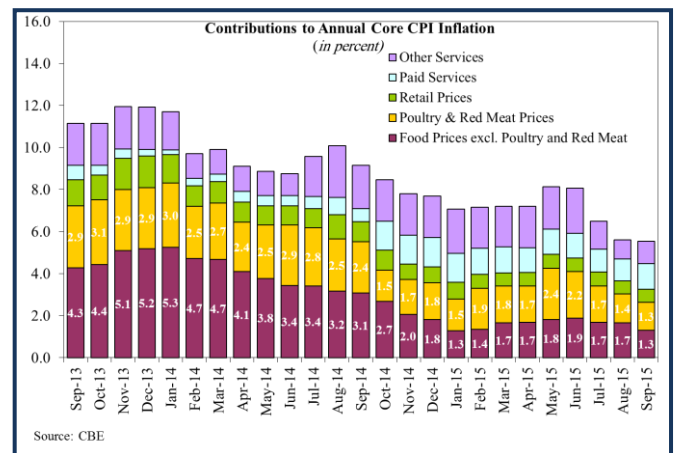
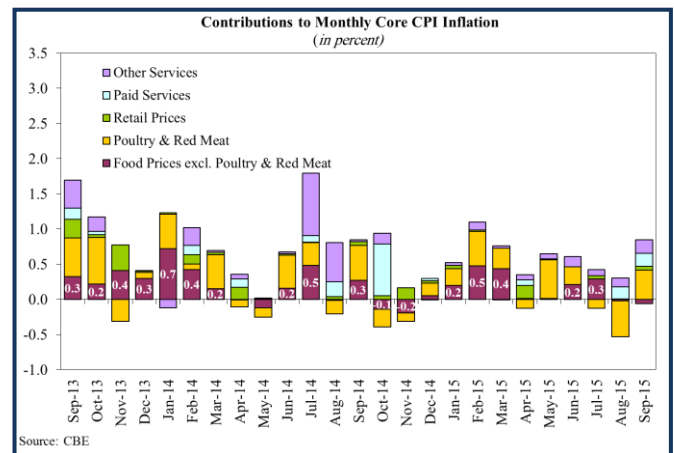
Key Highlights

- Prices of regulated items increased by 1.26 percent (m/m) in October, contributing by 0.24 percentage points to monthly headline inflation. This month's increase is attributed to the increase in the prices of public school tuition by 5.05 percent, public lessons by 18.04 percent and student dormitories by 8.97 percent, in addition to the adjustment in the prices of tobacco by 0.65 percent.
- The prices of fresh vegetables and fruits increased in October by 9.71 and 0.68 percent (m/m), respectively. Together, they contributed by 1.10 percentage points to monthly headline inflation.



- The prices of poultry declined in October by 2.27 percent (m/m), to contribute by negative 0.11 percentage points to monthly headline inflation. In the meantime the prices of red meat remained stable in October .
- Moreover, the prices of eggs increased by 2.15 percent (m/m) in October to contribute by 0.05 percentage points to monthly headline inflation.
- Prices of fish and sea food declined by 4.27 percent (m/m) in October, contributing by negative 0.13 percentage points to monthly headline inflation .
- While the prices of number of food items including milk, butter (imported), pulses and wheat flour, picked up to jointly contribute by 0.19 percentage points to monthly headline inflation.
- The prices of paid services increased by 7.88 percent (m/m) in October to contribute by 0.45 percentage points to monthly headline inflation. On the back of the increase in the prices of private lessons, tailoring, laundry and shoe repair and nursery services.
- The prices of other services increased by 1.80 percent (m/m) in October to contribute by 0.33 percentage points to monthly headline inflation, which was mainly driven by the increase in the prices of restaurant services and private schools.
- the prices of retail items increased slightly by 0.57 percent (m/m) in October to contribute by 0.06 percentage points to monthly headline inflation, which was mainly due to the increase in the prices of cars and motor cycle and books.

mentioned paid services, other services and retail items which contributed by 1.24 percentage points to monthly core inflation. While food items remained broadly unchanged.



1/ CAPMAS publishes three CPI series: (1) the CPI for urban areas which include Cairo, Alexandria, urban Lower Egypt, urban Upper Egypt, Canal cities and Frontier governorates, (2) the CPI for rural areas, and (3) the CPI for All areas. Numbers quoted in this note refer to CPI-Urban .

2/ It is important to underscore that the monthly percentage changes of both headline and core CPI between September 2009 and July 2010 do not match rates of changes presented in previous inflation notes given the replacement of the 8th CPI series by the 9th series starting from August 2009 (Full details are discussed in the Technical Appendix of the August 2010 Inflation Note).

2. Core Inflation²

Core CPI computed by the Central Bank of Egypt, increased by 1.23 percent (m/m) in October 2015 compared to an increase by 0.79 percent (m/m) in September, which is above the average monthly pace of 0.53 percent recorded during the first nine months of 2015. The annual rate increased to 6.26 percent in October from 5.55 percent in September.

The monthly dynamics in October was mainly driven by the developments in the prices of the previously
