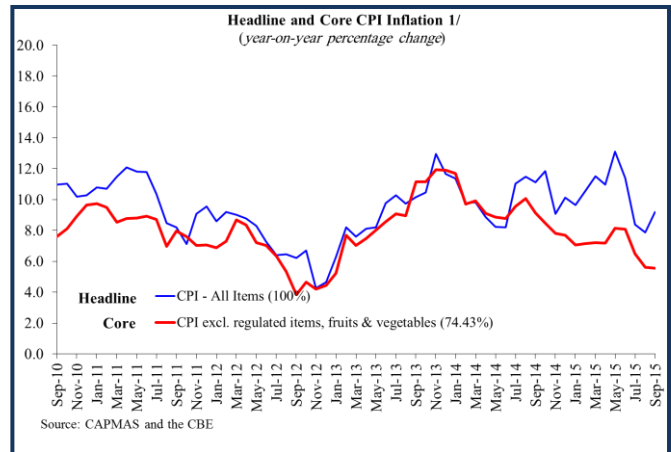
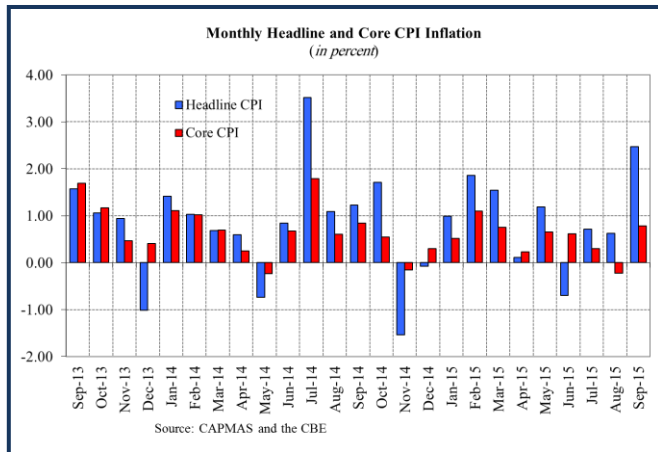


Headline and Core Inflation – September 2015

Headline CPI published by the Central Agency for Public Mobilization and Statistics on October 8, 2015, increased by 2.47 percent (m/m) in September 2015 compared to an increase by 0.63 percent (m/m) in August. The annual rate increased to 9.21 percent in September from 7.88 percent in August. The bulk of the monthly increase was driven by the acceleration in the prices of fresh vegetables and the increase in the prices of other food especially red meat and poultry, in addition to the increase in the prices of paid services and restaurant services. Meanwhile, core CPI computed by the Central Bank of Egypt increased by 0.79 percent (m/m) in September 2015 compared to a decline of 0.23 percent (m/m) in August. The annual rate remained largely unchanged in September at 5.55 percent, on the back of a favorable base effect from the previous year. Meanwhile, the prices of paid services, other services and retail items increased by varying degrees¹.

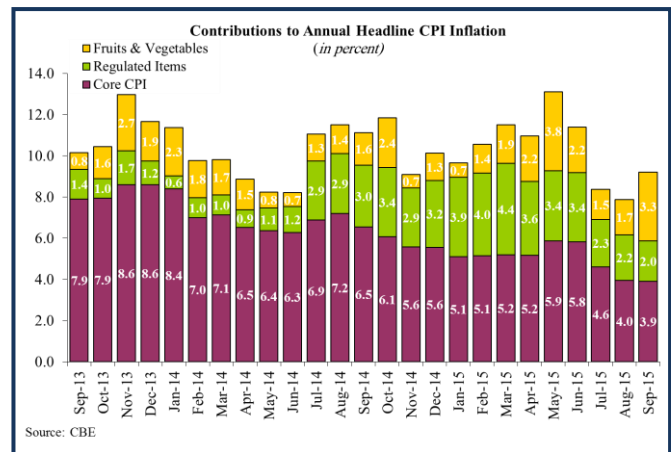
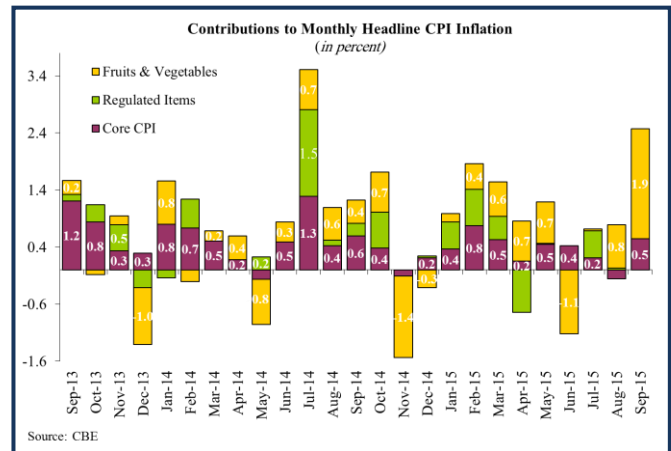


1. Headline CPI²

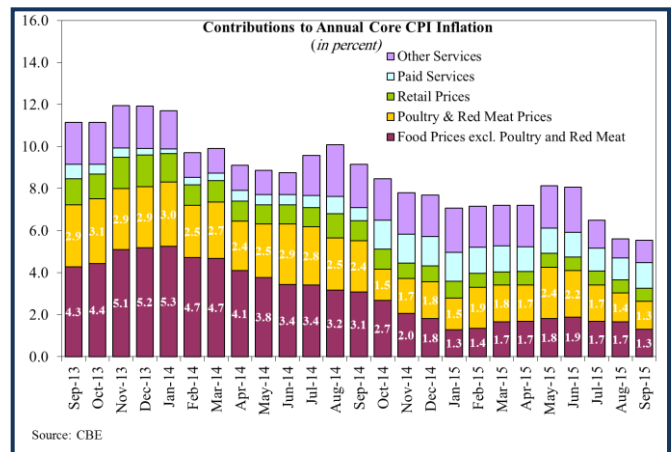
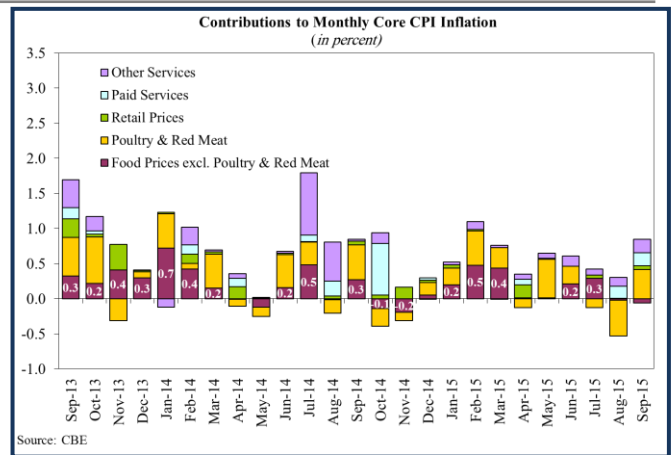
Headline CPI increased by 2.47 percent (m/m) in September 2015 compared to an increase by 0.63 percent (m/m) in August, which is above the average monthly pace of 0.79 percent recorded during the first eight months of 2015. The annual rate increased to 9.21 percent in September from 7.88 percent in August.

Key Highlights

- The prices of fresh vegetables and fruits increased in September by 19.95 and 1.18 percent (m/m), respectively. Together, they contributed by 1.93 percentage points to monthly headline inflation.
- The prices of poultry and red meat increased in September by 1.70 and 2.73 percent (m/m), respectively. Together, they contributed by 0.29 percentage points to monthly headline inflation.
- Moreover, the prices of eggs declined by 3.71 percent (m/m) in September to contribute by negative 0.08 percentage points to monthly headline inflation.



- Prices of fish and sea food declined by 3.70 percent (m/m) in September, contributing by negative 0.12 percentage points to monthly headline inflation .
- The prices of paid services increased by 2.23 percent (m/m) in September to contribute by 0.13 percentage points to monthly headline inflation. On the back of the increase in the prices of outpatient services.
- The prices of other services increased by 0.73 percent (m/m) in September to contribute by 0.13 percentage points to monthly headline inflation, which was mainly driven by the increase in the prices of private hospital, Haj and Omra trip and restaurant services.
- the prices of retail items increased slightly by 0.29 percent (m/m) in September to contribute by 0.03 percentage points to monthly headline inflation, which was mainly due to the increase in the prices of clothing and HH textile.



2. Core Inflation²

Core CPI computed by the Central Bank of Egypt, increased by 0.79 percent (m/m) in September 2015 compared to a decline by 0.23 percent (m/m) in August, which is above the average monthly pace of 0.49 percent recorded during the first eight months of 2015. The annual rate remained largely unchanged in September at 5.55 percent, on the back of a favorable base effect from the previous year.

The monthly dynamics in September was broad-based driven by the developments in the prices of the previously mentioned food items which contributed by 0.36 percentage points to monthly core inflation. This was coupled with higher prices of other services, paid services and retail items, which contributed by 0.19, 0.19 and 0.05 percentage points, respectively to monthly core inflation.

1/ CAPMAS publishes three CPI series: (1) the CPI for urban areas which include Cairo, Alexandria, urban Lower Egypt, urban Upper Egypt, Canal cities and Frontier governorates, (2) the CPI for rural areas, and (3) the CPI for All areas. Numbers quoted in this note refer to CPI-Urban .

2/ It is important to underscore that the monthly percentage changes of both headline and core CPI between September 2009 and July 2010 do not match rates of changes presented in previous inflation notes given the replacement of the 8th CPI series by the 9th series starting from August 2009 (Full details are discussed in the Technical Appendix of the August 2010 Inflation Note).
